Community Food Projects should be designed to (1): (A) meet the food needs of low-income people; (B) increase the self-reliance of communities in providing for their own food needs; and (C) promote comprehensive responses to local food, farm, and nutrition issues; and/or (2) meet specific state, local, or neighborhood food and agriculture needs for (A) infrastructure improvement and development; (B) planning for long-term solutions; or (C) the creation of innovative marketing activities that mutually benefit agricultural producers and low-income consumers.

Eligibility criteria for TAT grants is as follows: (a) Entities eligible for grants must be private nonprofit organizations with tax exempt status, designated by the Internal Revenue Service. A nonprofit organization is defined as any corporation, trust, association, cooperative, or other organization that: (1) Is operated primarily for scientific, education, service, charitable, or similar purposes in the public interest. (2) Is not organized primarily for profit. (3) Uses its net proceeds to maintain, improve, and/or expand its operations. (b) Entities must be legally established and located within a state as defined in 1775.2. (c) Organizations must be incorporated by December 31 of the year the application period occurs to be eligible for funds. (d) Private businesses, Federal agencies, public bodies, and individuals are ineligible for these grants. (e) Applicants must also have the proven ability, background, experience (as evidenced by the organization's satisfactory completion of project(s) similar to those proposed), legal authority, and actual capacity to provide technical assistance and/or training on a regional basis to associations as provided in 1775.33. To meet the requirement of actual capacity, an applicant must either: (1) Have the necessary resources to provide technical assistance and/or training to associations in rural areas through its staff, or (2) Be assisted by an affiliate or member organization which has such background and experience and which agrees, in writing, that it will provide the assistance, or (3) Contract with a nonaffiliated organization for not more than 49 percent of the grant to provide the proposed assistance.

Funds may be used to pay expenses associated with providing technical assistance and/or training (TAT) to identify and evaluate solutions to water problems relating to source, storage, treatment, and distribution, and

to waste disposal problems relating to collection, treatment, and disposal; assist applicants that have filed a preapplication with RUS in the preparation of water and/or waste disposal loan and/or grant applications; and to provide training that will improve the management, operation and maintenance of water and waste disposal facilities. Grant funds may not be used to recruit applications, duplicate current services such as those performed by a consultant in developing a project, fund political activities, pay for capital assets, purchase real estate or vehicles, improve and renovate office space or repair and maintain privately owned property, pay construction or O&M costs, and pay costs incurred prior to the effective date of grants made.

The Secretary of Agriculture has a congressionally designated advisory Council that assists the U.S. Forest Service in establishing the grant categories and recommending the final proposals for the Forest Service to consider. This is the National Urban and Community Forestry Advisory Council (Council). The Council supports urban and community forestry projects that have national or multi-state application and impact through the U.S. Forest Service's competitive Urban and Community Forestry Challenge Cost-Share Grant Program. A proposal's content must meet the Urban and Community Forestry program authorities as designated by Congress in the Cooperative Forestry Assistance Act, (Section 9) [Section 9 Urban and Community Forestry only (PDF, pp. 19-24)] and the annual criteria set forth by the Council. A listing of the previously funded projects can be viewed at www.urbanforestrysouth.org/research/nucfac Available Funding: The U.S. Forest Service anticipates that the statutory authority for the Fiscal Year 2013 Urban and Community Forestry (U&CF) Program will provide, under the Cooperative Forestry Assistance Act (Section 9), approximately \$900,000 in grant funds to be awarded through the 2013 National Urban and Community Forestry Challenge Cost-Share Grant Program. Funds are to support urban and community forestry projects on nonfederal public land that have a national or widespread impact and application. All awards are based on the availability of funding, which may be subject to change. Eligible Applicants: Any U.S. non-Federal organization, operating within the United States or its territories, may apply for the Challenge Cost-Share grant. While collaboration with Federal agencies is encouraged, a Federal agency may not receive funding or be used as match to the Federal funds being requested. (Conflict of interest issues will be addressed appropriately.) Individuals, commercial businesses or private land are not eligible. Note: Local tree-planting projects, capital improvements to property of any ownership, and/or projects that have only a local impact and applicability will not be considered for funding. Urban and community forestry projects with a local scope of work should contact their State Urban and Community Forestry Coordinator for assistance in identifying funding alternatives at the local level. The list of State Coordinators may be found at the following website: http://www.fs.fed.us/ucf/Related_Links/UCF_State_coordinators.htm. Matching Requirements: All grant funds must be matched at least equally (dollar for dollar) with non-Federal source funds. This match may include in-kind donations, volunteer assistance, and private and public (non-federal) monetary contributions. All matching funds must be specifically related to the proposed project. The source of matching funds must be identified and grantees must comply with all applicable Federal regulations. The National Urban and Community Forestry Advisory Council is seeking innovative grants proposals for program development, research, and collaboration to address the following two strategic priority issues widely seen as confronting the urban and community forestry

community at a national or multistate level. • Innovative proposals that demonstrate the connection between the personal benefits of urban forests and quality of life within a community through community engagement; and • Design an urban forestry recruitment program and retention strategies that support existing urban forestry academic curriculum. Organizations, local governments, tribal agencies, and partnerships are encouraged to submit proposals that will demonstrate the reach, resources, and expertise needed to address the two priority issues in ways that will lead to meaningful, replicable results. Potential Innovation grantees are encouraged to work collaboratively with other organizations and entities not traditionally involved in urban and community forestry. Applicants should consider multi-year projects and other sources of funds, including other Federal cooperative conservation sources. (Note: Federal dollars, in-kind services or donated materials may NOT be used as match to this grant program). As much as \$900,000.00 is available in FY 2013 for three or more Innovation Grants. Grant Category 1: Create an outreach program, pilot project or series of initiatives that communicates the connection between the personal benefits of urban forests and quality of life within a community through community engagement. Approaches must include the following: • educate distinct segments of the public about the benefits of urban forests; • mobilize individual action to help plant and care for trees on community property and their own private property; • engage community groups to take responsibility for their local environment; • make urban forestry a key component of planning for a community's future. The intended results must be directed toward mobilizing individual or community action and policy integration. The best practices or initiatives that result from the project would be designed for adoption or integration into local land use planning efforts in similar cities, towns or villages. Grant Category 2: Design an urban forestry recruitment program and retention strategies that support urban forestry academic curriculum. • Result in a measurable increase to the baseline number of students enrolled in urban forestry as their chosen major or those with declared concentrations, or minors in urban forestry; • Increase the proportion of students enrolled in natural resources disciplines who seek post-graduation positions in urban and community forestry settings; and • Can be replicated for application in other schools. • Applicants should review the Society of American Foresters (SAF) list of schools and accreditation criteria when developing their proposal. 

Modifications To Fire Stations And Facilities Grant Applicants: Prepare For Environmental And Historic Preservation (EHP) Reviews

Federal laws and regulations require that all AFG-funded projects for modifications to fire stations and other facilities undergo an Environmental and Historic Preservation (EHP) review and receive EHP clearance **before any work begins and before any project funds are spent**. FEMA must consider the potential impact of all projects funded on natural and cultural resources, and this is accomplished through FEMA's EHP Review process.

If you requested a modifications to facilities grant, start preparing now by gathering the information that will be needed for the EHP screening. You will be asked to provide the following for each modifications project awarded:

- Age of the structure(s)
- Address of the structure(s)
- Description of how the structure will be modified, e.g., how the equipment will be installed or the renovations made
- Clear, good quality exterior photographs of the structure(s), assuming the modification will be visible from the outside
- Clear, good quality interior photographs that show where equipment will be installed or where the renovations will be made
- Technical drawings, maps, or site plans, if applicable
- Documentation of any previous EHP-related statements or reviews

Multiple Projects

If your grant includes funding for other AFG project activities in addition to the fire station or facilities modification, like personal protective equipment or training projects, you may access those project funds immediately. To do this, send an e-mail to AFG requesting that the grant funds be released and affirming that you will not proceed with your modification project until the EHP review has been completed and approved.

Common Reasons for Delays in EHP Reviews

By planning ahead, you can avoid some of these problems that can delay the completion and approval of EHP reviews:

- Poor or absent ground-level photographs
- Poor or absent aerial photographs
- Inadequate project description
- Inadequate information on project location (no physical addresses or latitude-longitude)





The National Science Foundation funds research and education in most [fields of science and engineering](#). It does this through grants, and cooperative agreements to more than 2,000 colleges, universities, K-12 school systems, businesses, informal science organizations and other research organizations throughout the United States. The Foundation accounts for about one-fourth of federal support to academic institutions for basic research.

NSF receives approximately 40,000 proposals each year for research, education and training projects, of which approximately 11,000 are funded. In addition, the Foundation receives several thousand applications for graduate and postdoctoral fellowships.

The agency operates no laboratories itself but does support National Research Centers, user facilities, certain oceanographic vessels and Antarctic research stations. The Foundation also supports cooperative research between universities and industry, US participation in international scientific and engineering efforts, and educational activities at every academic level.

Since the inception of the program, ASHA has assisted 237 institutions in over 70 countries, and facilitated the development and sustainment of superior libraries, schools, and medical centers, thus positively impacting the regions where these institutions are located.

Child Survival and Health Grants Program
The Child Survival and Health Grants Program (CSHGP) promotes a unique and productive partnership with U.S. private voluntary and non-profit organizations and their in-country partners. The program supports effective community-based maternal and child health programs that contribute to reducing infant, child, maternal and infectious disease-related mortality and morbidity in developing countries. PVOs and their local partners provide high quality, sustainable child survival and health interventions in a variety of program settings, from the smallest, most remote communities to large, district-wide programs, partnering with community groups and district and national health authorities.

Denton Program (Transportation)
The Denton Program allows private U.S. citizens and U.S. based non-governmental organizations to use space available on U.S. military cargo planes to transport humanitarian items such as clothing, food, medical and educational supplies, agricultural equipment and vehicles to countries in need. The program is jointly administered by USAID, the Department of State (DOS), and the Department of Defense (DoD). In FY 2003, over 300,000 pounds of humanitarian goods were sent to seven countries through the Denton program.

Since the Denton program is a space available program, it is impossible to predict when transportation will materialize. Therefore, no guarantees can be made regarding completion of a shipment. Although the program is active in most areas of the world, U.S. military engagement in certain places can have an impact on the space that becomes available.

Development Grants Program (DGP)
The Development Grants Program is a competitive small grants program, initiated in 2006, that provides opportunities for organizations that have limited or no experience managing direct USAID grants. DGP was designed to expand the number of direct partnerships and to build the capacity of organizations to better meet the needs of their constituents. Successful applicants receive awards for \$2 million or less to implement activities over a three-year period.

Development Innovations Venture (DIV)
USAID launched Development Innovation Ventures (DIV) as a way of producing development outcomes more effectively and cost-efficiently while managing risk and obtaining leverage. Through DIV, USAID seeks to identify and rigorously test promising projects with the potential to significantly (rather than incrementally) improve development outcomes, and help replicate and scale projects that are proven successful. DIV expects its most successful investments will have an accelerated growth path to reach tens of millions of beneficiaries worldwide within 10 years.

Food for Peace
USAID, through funding provided by Public Law 480, Title II, makes commodity donations to Cooperating Sponsors (Private Voluntary Organizations, Cooperatives, and International Organization Agencies) to address the needs of food security in both 5-year development projects and emergency food assistance programs. Food for Peace provides assistance primarily through three types of programs:

The Small Business Innovative Research Program - SBIR Program

The Small Business Innovation Research (SBIR) program is a highly competitive program that encourages domestic small businesses to engage in Federal Research/Research and Development (R/R&D) that has the potential for commercialization. Through a competitive awards-based program, SBIR enables small businesses to explore their technological potential and provides the incentive to profit from its commercialization. By including qualified small businesses in the nation's R&D arena, high-tech innovation is stimulated and the United States gains entrepreneurial spirit as it meets its specific research and development needs.

SBIR Mission and Program Goals

The mission of the SBIR program is to support scientific excellence and technological innovation through the investment of Federal research funds in critical American priorities to build a strong national economy.

The program's goals are four-fold:

- Stimulate technological innovation
- Meet Federal research and development needs.
- Foster and encourage participation in innovation and entrepreneurship by socially and economically disadvantaged persons.
- Increase private-sector commercialization of innovations derived from Federal research and development funding.

SBIR-Participating Agencies

SBIR Phase I awards normally do not exceed \$150,000 total costs for 6 months.

Phase II. The objective of Phase II is to continue the R/R&D efforts initiated in Phase I. Funding is based on the results achieved in Phase I and the scientific and technical merit and commercial potential of the project proposed in Phase II. Only Phase I awardees are eligible for a Phase II award. SBIR Phase II awards normally do not exceed \$1,000,000 total costs for 2 years.

Phase III. The objective of Phase III, where appropriate, is for the small business to pursue commercialization objectives resulting from the Phase I/II R/R&D activities. The SBIR program does not fund Phase III. Some Federal agencies, Phase III may involve follow-on non-SBIR funded R&D or production contracts for products, processes or services intended for use by the U.S. Government

Socially and economically disadvantaged small business concerns and women-owned small business concerns are particularly encouraged to participate. For an SBIR Phase I Proposal, a minimum of two-thirds of the research, as measured by the budget, must be performed by the small business concern and the balance may be outsourced to a consultant or subcontractor or a

combination of the two. Proposals from joint ventures and partnerships are permitted, provided the entity created qualifies as a [small business concern](http://www.nsf.gov/eng/iip/sbir/definitions.jsp#sbc). Proposing firms are also encouraged to take advantage of research expertise and facilities that may be available to them at colleges, universities, national laboratories, and from other research providers. The Small Business Innovation Research (SBIR) Program stimulates technological innovation in the private sector by strengthening the role of small business concerns in meeting Federal research and development needs, increasing the commercial application of federally supported research results, and fostering and encouraging participation by socially and economically disadvantaged and women-owned small businesses. The SBIR program solicits proposals from the small business sector consistent with NSF's mission. The program is governed by Public Law 112-81 (SBIR/STTR Reauthorization Act of 2011). A main purpose of the legislation is to stimulate technological innovation and increase private sector commercialization. The NSF SBIR program is therefore in a unique position to meet both the goals of NSF and the purpose of the SBIR legislation by transforming scientific discovery into both social and economic benefit, and by emphasizing private sector commercialization. Accordingly, NSF has formulated broad solicitation topics for SBIR that conform to the high-technology investment sector's interests.
